DESCRIPTION

HOCUT 807 is a low odour, bio stable, soluble, EP cutting fluid designed to give extended emulsion life. It mixes readily with water to provide excellent corrosion protection and lubricating properties.

HOCUT 807 is phenol-free and is formulated from solvent refined mineral oil and a composite emulsifier, anti-corrosion, EP lubricating system, providing long emulsion life without the problems associated with coolant degradation, caused by bacterial and fungal contamination. The high degree of corrosion protection has been achieved without the use of nitrite or other undesirable components.

HOW TO USE

The recommended usage concentration of **HOCUT 807** for ultimate coolant life the emulsion should be maintained above 5% concentration. This may be customised to suit individual needs or solutions, which may vary from time to time.
